Terms of use for the "Teuto Kletterpark" at the "Hermannsdenkmal"

1. Each participant has to read these terms of use before entering the climbing park. He confirms with his signature, that he took note of these terms of use and that he agrees on them. The legal guardians of the underage participant have to read these terms of use and explain them to the underage participant before he is allowed to enter the climbing park. They confirm with their signature that they read these terms of use, explained them to the underage participant and that they agree with them.

2. The use of the climbing park is connected with risks and it is effected at one's own peril. Only the respective user is responsible for the abidance of the terms of use. The liability of the Interakteam GmbH is mentioned in point no. 8.

3. The following conditions apply for the use of the climbing park:

- a) An average physical fitness is presupposed.
- b) Children at the age from 9 years on can participate from a grab height (stretched arm upward) of 1.85 m.
- c) Children at the age of under 12 have to be in company of an adult (attended group programs are an exception.)
- d) Persons suffering from a physical or psychological impairment are not entitled to enter the park, because they could represent a danger for the security of the participants or other persons.
- e) Persons that are under the influence of alcohol or of other drugs are not entitled to enter the park.
- f) Max. weight: 120 kg
- g) Articles that could represent a danger for the participant himself or for other people are not allowed to be carried along when entering the climbing park (for example jewellery, mobile phones, cameras, ...)

4. Each participant has to take part in the safety demonstration before entering the climbing park. All instructions and decisions of the organizer are binding. In case of offences against the instructions or the safety assignments of the organizer, the participants concerned could be ostracised from the climbing park. In case of offences against instructions or safety requirements of the organizer, the Interakteam GmbH does not assume liability for the damage arisen.

5. The borrowed equipment (helmet, belt, safety line with carabiners) must be used under the instructions of the organizer. It is not transferable to others, it is not allowed to doff it during the stay in the climbing park and it has to be returned 3 hours after the handing over. While climbing, the safety carabiners must be hooked into the safety line in opposite directions (from two sides). While relocating the line, one safety carabiner must always be hooked in. Both safety carabiners are not allowed to be hanged out. In case of doubt an organizer must be contacted.

6. Entering the purple parcours and the black parcours is only allowed if it has been arranged with a trainer of the company Interakteam before. Every station may be entered by max. 1 person. Max. 3 persons may stay on the platforms at the same time.

7. The management reserves itself the right to exclude participants from the park, if they do not observe the terms of use. The management also reserves itself the right to discontinue the service because of safety-related reasons (fire, storm, and thunderstorm). In this case, reimbursement of the admission price is not effected.

8. The Interakteam GmbH is liable for personal injuries in line with the legal requirements. The Interakteam GmbH is only liable for property damage and financial loss, if intention or gross negligence of their legal agents or members of staff are existent.
