**§ 1 General terms**

- 1. The use of the climbing park and their incorporated facilities and objects are exclusively subject to these terms of use. Conflicting or deviating terms of use of participants will not be recognised.
- 2. Separate terms of use may apply for individual facilities within the park (Black course, Bambini courses, Pole-facility). Interakteam GmbH personnel will inform participants individually about the content and application of these further terms of use at the relevant facility. The participants must respect descriptive signs.
- 3. It is prohibited to leave the designated and marked paths and areas. Existing barriers must be respected by participants at all times.

**§ 2 Scope of the services owed**

- 1. Against payment, participants are entitled to use the entire climbing park for the booked duration.
- 2. For any safety reasons concerning the participants or arising from the weather, Interakteam GmbH is entitled to cancel, limit or, if necessary, interrupt the use of the climbing park. The rights of the users, especially according to § 314 BGB and §§ 323, 346 et seq. BGB, remain unaffected in this case.

**§ 3 Requirements for use of the climbing park/ conduct of participants**

- 1. Making use of the climbing park while under the influence of narcotics and/or alcohol is absolutely prohibited. Further, participants have to respect and regard other participants and their well being.
- 2. The forest climbing routes are suitable for children from the age of 8, and with a grip height of at least 1.85m (outstretched arm over the head). The Pole-Facility at the climbing park in Bielefeld is suitable for children from the age of 8 with a grip height of at least 1.65m. The Black courses are suitable for participants from the age of 14 and a grip height of at least 2.00m. The use of all climbing courses is only possible when a participant is in the company of at least one climbing partner. The use of the climbing park requires a sufficient level of physical fitness. Participants who do not fulfil this requirement, who are pregnant or who are suffering from a physical or psychological impairment are excluded from the use of the climbing park. If one of the preceding reasons for exclusion is not declared and is first detected by safety personnel, the participant will be excluded from further use of the climbing park without reimbursement of the entrance fee.
- 3. With regard to safety equipment, Interakteam GmbH is entitled to exclude participants from participation in climbing park activities who exceed a maximum weight of 120 kg.
- 4. Every participant has to take part in the obligatory safety instruction before making use of the climbing park facilities. Participants must comply with all instructions from Interakteam GmbH personnel. Repeated violation of instructions from Interakteam GmbH personnel can lead to exclusion from the use of the climbing park, if Interakteam GmbH personnel observe and justify a culpable breach by the participant.
- 5. For safety reasons, objects that could present a danger to the participant or others are not allowed to be carried along or on the body (i.e. jewelry, mobiles, cameras, scarfs, and piercings). Long hair must be tied up in a bun. It is absolutely necessary to wear closed, robust shoes. Failure to follow these instructions will result in exclusion from further use of the climbing park without reimbursement of the entrance fee.

- 6. Minors are only allowed to use the climbing park when supported by the necessary written consent of the legal guardian or a supervision entitled adult. The completed and signed consent form is to be presented to Interakteam GmbH personnel on arrival at the climbing facilities. The relevant document is available at the climbing park cashier counter or at www.kletterpark.de as a download. Additionally, children up to and including the age of 10, are solely allowed to use the forest climbing routes in the company of a supervision entitled adult. One supervision entitled adult is permitted to accompany a maximum of 2 children. Deviating regulations at individual stations / courses are to be respected and complied with.

**§ 4 Liability of the organiser**

- 1. Interakteam GmbH, its legal representatives or vicarious agents are only liable in cases of willful intent or gross negligence. The organiser is also liable in cases of ordinary negligence if significant obligations were violated, although limited to the foreseeable damage typical for a contract. Hereof unaffected remain damages to life, body or health and according to mandatory liability regulations.

**§ 5 Bringing valuables to the facilities**

- 1. Participants are explicitly advised not to bring any valuables to the climbing park. The side of the organiser does not owe any sort of safekeeping or guarding of valuables.
- 2. Depositing money or valuables in a storage space or box provided by Interakteam GmbH does not justify any further safekeeping or guarding responsibilities for the organiser in regard to the deposited valuables. Therefore there is no safekeeping or guarding of provided storage possibilities taking place.

**§ 6 Equipment/Rental**

- 1. Interakteam GmbH provides safety equipment for the participants in order to enable them to safely use the climbing park and included facilities and stations. The borrowed equipment must not be passed on to another person or taken off, unless an Interakteam GmbH Interakteam personnel explicitly permits it. Further, the borrowed equipment must be used according to the instructions of the organiser/instructor and returned to the organiser when leaving the facility.
- 2. The use of participant’s own safety equipment is prohibited.
- 3. The participant is required to treat the borrowed safety equipment with the required care. The safety equipment is solely to be used for the intended use and following the instructions of the safety personnel.
- 4. It is prohibited to use the toilet facilities or smoke while wearing the safety equipment.

**§ 7 Personal data**

- 1. The organiser will not transfer any personal data to third parties. Otherwise, personal data will only be transferred to third parties if the participant has explicitly consented or a legal obligation exists to transfer the data. Insofar as the participant has given his explicit consent, the participant can revoke this at any time through a simple notification with effect to the future (i.e. email, letters, etc.). Contract data processing does not take place. The organiser will not store data longer than for contract processing necessary. If the participant wishes to get information about the stored data, a simple request to the organiser is sufficient (i.e. email, letter, etc.).
- 2. Interakteam GmbH reserves the right to take photos and video recordings for commercial and information purposes. If a participant does not agree with this, they have the right to explicitly inform the organiser beforehand.
