TERMS OF USE FOR ARCHERY

1. Each participant has to read these terms of use carefully before starting archery. They confirm with their signature, that they took note of these terms of use and that they agree to them. Parents or legal guardians of a minor participant have to read these terms of use and explain them to the minor before they are allowed to do archery.
2. The use of bow and arrow is entirely at your own risk. The user is responsible to abide by the terms of use. The liability of Interakteam GmbH is mentioned in point 8.
3. The following terms apply to the use of bow and arrow:
 - a. Children are allowed to participate at a minimum age of 12 years (respectively from 7th grade when with their class).
 - b. Persons suffering from a physical or psychological impairment that could represent a danger to the security of the participant or other people, are not entitled to participate in archery. Especially people with impairments of the skeletal and locomotor system and/or with hear complaints, circulation problems.
 - c. Persons under the influence of alcohol or drugs are not entitled to take part in the program.
 - d. Chewing gum and candy are not permitted due to safety reasons.
 - e. Wearers of glasses are advised to take the same precautions as in participating in any other sports.
4. Each participant has to take part in a safety briefing. All instructions, orders and decisions of the organiser/trainer are binding. In case of offences against instructions or safety rules of the organiser/trainer the participant concerned can be removed from the program. In case of such offences the organiser (Interakteam GmbH) does not assume liability.
5. Borrowed equipment (bow, arrows, arm guards) must be used according to the instructions of the organiser/trainer. It has to be returned after the program. The equipment has to be kept away from fire (cigarettes) and has to be left when visiting the toilet or leaving the range.
6. The organiser/trainer can exclude participants from the program if they do not follow the terms of use. The management reserves the right to discontinue the service because of safety reasons (fire, storm, thunderstorm etc.). In that case reimbursement of admission does not occur.
7. Interakteam has the right to take photographs for advertising purposes. Participants that disagree with this term have to inform the trainers of Interakteam before participating in the program.
8. Interakteam GmbH is liable in line with the legal requirements.
